Request an Extension of a Filing Deadline

Charitable organizations and charitable trusts may request extensions of the date by which they must file their annual reporting materials. This email will also identify the new date by which the charity or charitable trust must file its annual report. You should receive this email within 24 hours of properly submitting your extension request. If you do not receive an e-mail, it may be because your request was not properly submitted, you provided an inaccurate email address, or the email response to your extension request was filtered into a spam email folder. If multiple extension requests were submitted for different organizations, email should be received for each request. Charities and charitable trusts should save all emails granting extension requests for their records.
